Procurement: Construction of Trial Bridge at Trishulighat (Baralunge Ghat) under Lump Sum Contract (Construction Turnkey Package [CTP])

Bidding is open to all eligible Nepalese Bidders.

The Aanbookhaireni Rural Municipality invites sealed bids from registered contractors for the construction of the following Long Span Trail Bridges (LSTB) on Construction Turnkey Package (CTP) basis from eligible Civil Contractors. Bidders Average Annual Construction Turnover and Experience requirements are given below. Detailed Evaluation and Qualification Criteria are provided in Section 3 of the Bid Documents.

Bidding documents may be purchased from the office of **Aanbookhaireni Rural Municipality,Aanbookhaireni Tanahun or www.bolpatra.gov.np/egp** by eligible Bidders, on the submission of a written application and upon payment of a non-refundable fee for tender documents as mentioned in the following table, until the office hours of 30th (11th june,2019) days from the first date of publication of this notice.
- 5. Bids must be submitted to the office of Aanbookhaireni Rural Municipality, Aanbookhaireni Tanahun or Electronic bids must be submitted through PPMO website <a href="www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a>, on or before 12th june 2019 12:00 PM noon .Documents received after this deadline shall not be accepted.
- 6. Bids will be opened in the presence of Bidders' representatives who choose to attend at 12th june 2019 14:00 PM at the office of Aanbookhaireni Rural Municipality, Aanbookhaireni Tanahun. Bids must be valid for a period of 90 days after bid opening and must be accompanied by bid security, amounting to a minimum of 2.5 % of the quoted Bid amount (inclusive of VAT), which shall be valid for 30 days beyond the bid validity period.
- 7. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Macchapuchre Bank Ltd. Aanbookhaireni branch Tanahun, Account Name: Aanbookhaireni Gaupalika, Account No. 2701524618454041 and submit the receipt of the deposited amount of cash along with the bid.
